New Business:

Repeater Problems

- Repeater is having problems and Dave is working to resolve them.
- Vern said no new equipment had been added at repeater site.
- Dave power cycled it, but it did not fix the problem.
- Dave and Vern will go to repeater site tomorrow (Oct 13th).

Repeater Access

- Vern will be retiring in the near future and will no longer have access to the repeater.
- Pat Collins is willing to help because he is friends with the repeater site owner.
- Jon is working on a back-up plan.
- Some discussion on the need to move the repeater to a location with easier access.

Delinking repeater from K-Link

- Question was raised about the possibility of delinking the repeater from K-Link.
- Some MAARS members do not use the repeater as they do not want their discussion broadcast across Kansas.
- Dave Mills said we would maintain capability with K-Link, but would be local most of the time.
- Dave Avery suggested the MAARS repeater and Clay Center repeater remain linked.
- Suggestion made to keep analog as is, but digital would allow separate local repeater.

- Jon suggested using the two repeaters at KSU for local traffic. These repeaters do not reach very far.
- Question raised whether nets used K-Link for nets. We could relink for nets, but nets could use Alma or Junction City repeaters.
- Pros for delinking repeater:
 - O It would free the repeater from the "Coffee Club" which dominates its use as MAARS members are on the way to work and cannot converse on our repeater
 - Would reduce wear and tear on our equipment
 - More MAARS members would talk on the air

Cons

- Would adversely affect users traveling across Kansas (Discussion led to users could use the linked Junction City Repeater)
- Would adversely affect emergency communications suggestion was made to relink repeater to K-Link during emergency/storm chasing events
- Motion was made to delink repeater. The club voted and the motion carried (one nay vote)

June Field Day

- Request was made for someone to volunteer to chair the event. Chair person would do general planning and then announce the location of the net.
- Dave Mills volunteered to chair the event, but needs help with logging apparatus and turning in results to ARRL. Bill, Ryan, Vern and Glen volunteered to assist.
